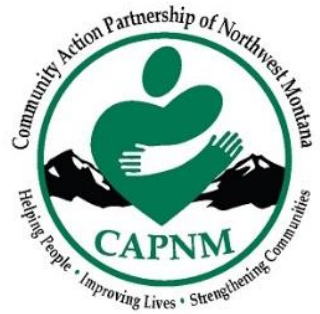


General Information for LIHEAP (Low Income Home Energy Assistance Program)

Applications are usually accepted October 1 - April 30 of each heating season. The following items are usually required:

- ▶ Complete **all sections** of the application, including your signature. Items that don't apply should be marked "**none**" or "**n/a**", not blank.
- ▶ **Include everyone** who resides in the home, even if they just moved in and/or are considered a "separate household" for other programs and/or do not help with expenses and/or are just renting a room in the home.
- ▶ Recent bill or "letter of service" from your one main **heating provider** and recent **electricity bill**.
- ▶ Verification of **all income**, from **all sources**, for **all current household members** – see below.
- ▶ **All pages** of statements received the month prior to the month you apply for LIHEAP – for **all bank/credit union accounts** for **all current household members**. Verification of the current balance of all Direct Express cards, ReliaCards, Direct Deposit payroll cards, CDs, IRAs, stocks, bonds, investments, TSAs, 401(k)s, 403(b)s, or any other retirement/investment accounts.

- LIHEAP applications are processed in the order they are received and processing can take up to 45 days.
- Energy Share of MT may be able to help if you have an energy "crisis" (past due/disconnect).
- LIHEAP benefits can only be used during the "heating season" of October 1 - April 30.
- Benefit amounts aren't based on energy usage and are for one main heat type only.
- If approved for LIHEAP, you'll also be added to the "priority list" for Weatherization.
